## COMMUNITY CURB APPEAL CHECKLIST

We encourage all residents to pay particular attention to the following maintenance items.

- **Trash.** No garbage or trash cans or receptacles shall be maintained in an exposed or unsightly manner. Please take your receptacles out **the evening prior to trash day** and bring in to store the **evening of trash day**. Please note that this means they **CANNOT BE STORED BETWEEN UNITS. Be prepared to receive penalties and fines for leaving your cans out.**
- **Pet Waste.** Please clean up after your pet. Pet waste stations have been placed throughout the community to help keep the community clean. We appreciate if everyone can do their part.

## ADDITIONAL ITEMS

- **No Parking in Alleys.** All alleyways are fire lanes and therefore designated as no parking areas throughout the community - these need to be adhered to. There could be very serious consequences by parking in those areas, as emergency vehicles may need access. **CARS PARKED IN ALLYS WILL BE TOWED.**
- **Towing Company.** Wyatts Towing is monitoring the community. If someone is blocking access to your unit or parking illegally in the fire lane you can contact Wyatt directly at 303-777-2448. \*Please indicate you are in Littleton Village MD and reference the address: [7377 S. Pennsylvania](#), which is the District's account address
- **Speeding.** Please obey the speed limit within the community and remember to always make sure the pedestrians see you before you proceed through intersections or pull out from driveways or parking lots.
- **Leashes for pets.** Please remember the Littleton Village Metro District and City of Littleton's policy regarding leashing of pets – ALL pets must be on a leash at ALL times, unless at a designated off-leash park. The fine for an unleashed pet is determined by the court and can be up to \$999.00.
